**“What is This About Hoarding, and What Do We Do About It?”**

According to Kate, hoarding is an expansion of a natural behavior. As human beings, we plan ahead and collect for things that we need. Hoarding becomes a problem when there is an excessive collection of things, interfering with day-to-day functioning. The behavior usually begins early in life, and can be a learned behavior. Hoarding is sometimes caused by an excessive compulsive disorder or an anxiety disorder, and can be accompanied by depression, ADD, or dyslexia. Risk factors include age, family history, and stressful life events. The result of hoarding is social isolation. There is no proven way to deal with hoarders; drugs have very little effect.

Kate challenged the SOA members to take a look at their lives and the lives of those around them to identify any potential hoarding tendencies. The best approach to take with a hoarder is to help them begin to discard and organize, as they become quickly overwhelmed. Identifying items to be passed along to family members is another way to help.
